Wholesale LIS Trades time extension on the expiry day – Standard Stock Options and Weekly Stock Options - Reminder

Summary

As of **4 November 2024**, the Wholesale LIS trades will be permitted until 18:30 CET/CEST during the expiry day on the Amsterdam, Brussels, Lisbon, Oslo and Paris Financial Derivatives markets for the following contracts:

- Standard Stock Options
- Weekly Stock Options

This change was applied in the Next-EUA environment on 11 October 2024.

Euronext reminds clients that the Wholesale LIS (Large-In-Scale) trading session on the Amsterdam, Brussels, Lisbon, Oslo and Paris Financial Derivatives markets will be extended until 18:30 CET/CEST on the expiry day of the following contracts:

- Standard Stock Options
- Weekly Stock Options

Currently, on the expiry day, the Wholesale LIS trades on the above-mentioned contracts are permitted only until the expiry time on the Central Order Book.

The extension of the Wholesale LIS trading session will be effective in the Production environment from **4 November 2024**.

As communicated in the Info Flash of [7 October 2024](#), this change has been available in the Next-EUA environment since 11 October 2024.
