Borsa Italiana migration to the new Core Clearing System - Resting Orders Cancellation prior the Go-Live

Summary

In relation to the migration of the Borsa Italiana markets to the new Core Clearing System, **all resting orders on the markets in scope for the migration will be cancelled** on **Friday 27 June 2025** after Market Closure (list of Markets and MIC codes in the body of this Info-Flash).

Following the Info Flash from <u>25 March 2025</u>, Euronext reminds clients that the migration of the **Borsa Italiana Equities, ETF and Financial Derivatives markets** to Euronext Clearing's **new Core Clearing System** is planned to Go-Live on 30 June 2025.

As announced in the **Market Notice n. 27524** of 13 June 2025, **on Friday, 27 June 2025**, after Market Closure, **Euronext will cancel all resting orders on the Borsa Italiana markets in scope** for the clearing migration:
