

# ~~2021~~2022 ADDENDUM TO THE EMDA ORDER FORM

This ~~2021~~2022 Addendum to the EMDA Order Form ("~~2021~~2022 Addendum") permits the Contracting Party to choose to apply the below list Oslo Børs reportable Information Products as described in the ~~2021~~2022 Addendum to the Euronext Information Product Fee Schedule (the "~~2021~~2022 IPFS Addendum") applicable from 1 January ~~2021~~2022 up to and including ~~31 December 2021~~30 September 2022.
