## **GENERAL**

This Information Product Fee Schedule describes the Information Products marketed by Euronext and the corresponding Fees. #### **BASIC CFD LICENCE FEES**

The Basic CFD Licence Fees apply once per Contracting Party, per Information Product.

If the values or prices resulting from CFD Use of the Information constitute Information, the applicable Redistribution Licence Fees, White Label Fees and Display Use Fees apply in accordance with the Euronext Market Data Agreement (EMDA) and in addition to the Basic CFD Licence Fee.

If a User has multiple accounts the Contracting Party is allowed to net these accounts with regard to the CFD User Fees, if it can be demonstrated that the account belongs to the same User. A Contracting Party needs to take into account all active accounts for CFD User Fees if this is not the case.
