GENERAL

This Addendum to the Information Product Fee Schedule (the "IPFS Addendum") describes Oslo Børs' reportable Information Products and the corresponding Fees and is applicable from 1 July 2020 up to and including 31 December 2020. This Addendum forms an integral part of the Addendum to the EMDA Order Form and the Agreement up to and including 31 December 2020. The Addendum will automatically terminate after 31 December 2020, without Euronext being required to give Notice of such termination.

This IPFS Addendum will form an integral part of the Agreement between the Contracting Party and Euronext, as well as the Euronext Subscriber Terms and Conditions of the Subscribers of that Contracting and its Affiliates, provided that the Contracting Party has successfully submitted to Euronext the relevant Addendum to the EMDA Order Form. In such case in respect of Oslo Børs Information only:

- The Oslo Børs Professional Use Fees are paid instead of the Euronext Display Use Fees described in the Information Product Fee Schedule;
- The Oslo Børs Private Use Fees (for Trading Members) are paid instead of the Euronext Non-Professional Fees described in the Information Product Fee Schedule; and
- The Oslo Børs Snapshot Fees are paid instead of the Euronext Page View Fees described in the Information Product Fee Schedule.

All capitalised terms used, but not defined herein have the same meaning as defined in the EMDA General Terms and Conditions or Euronext Subscriber Terms and Conditions.

All Fees stated in this IPFS Addendum to the Information Product Fee Schedule are identical to the Oslo Børs fees that are applicable until 30 June 2020 pursuant to the Oslo Børs 'Standard Information Distribution Agreement'. All Fees in this IPFS Addendum are in Norwegian Krones (NOK), excluding sales tax (VAT) and applicable per calendar month. Except where explicitly stated in this IPFS Addendum, Fees described in this IPFS Addendum are to be paid on a cumulative basis.

Unless otherwise specified, the Fees and Information Products described herein cover the Oslo Børs, Oslo Axess, Merkur Market, Nordic ABM and Oslo Connect markets, and the Oslo Børs APA service.

The Fees include neither technical access nor telecommunication charges.

Available Information is offered at different levels of depth. These levels are described in the following table:

Level 2

 The full depth of the order book of the applicable financial instrument(s) traded on the applicable market(s).

Level 2 also includes Level 1 and Last Price:

- The best bid and offer per financial instrument, i.e. prices and quantities, of the applicable financial instrument(s) traded on the applicable market(s) and the number of orders at each price level. It also includes the indicative matching price and volume.
- The traded prices and quantities, open, high, low and closing prices of the applicable financial instrument(s) traded on book and/or off book on the applicable market(s).
- The opening and closing messages relative to the characteristics of the financial instruments for the trading session.

PROFESSIONAL USE AND PRIVATE USE FEES

Oslo Børs Professional Use Fees and Oslo Børs Private Use Fees are charged for the right to Use Real Time Information Products in a display manner in accordance with the Euronext Market Data Agreement (EMDA) and/or applicable Euronext Subscriber Terms and Conditions. In respect of Oslo Børs Information only:

- the Oslo Børs Professional Use Fees are paid instead of the Euronext Display Use Fees described in the Information Product Fee Schedule; and
- the Oslo Børs Private Use Fees (for Trading Members) are paid instead of the Euronext Non-Professional Fees described in the Information Product Fee Schedule.

The Contracting Party and its Affiliates will not be charged Oslo Børs Professional Use Fees and Oslo Børs Private Use Fees for the Use of Delayed Information.

Oslo Børs Professional Use Fees and Oslo Børs Private Use Fees apply once per user which has the ability to access Real Time Information on the last day of the relevant calendar month, per Information Product.

The following definitions solely apply to Oslo Børs Professional Use Fees, Oslo Børs Private Use Fees, Oslo Børs Snapshot Fees and Oslo Børs Private Use Fees for Trading Members:

"Private Subscriber": A natural person (and not limited liability companies or other entities with limited liability, general partnerships, trust companies, associations, corporations, joint properties or any other entities whatsoever) who does not perform and is not in any other way engaged in giving investment services. A Private Subscriber may only use the information for Private Use as defined under "Private Use" below.

A natural person or corporation, partnership or other entity authorised to give investment services or registered or qualified in any capacity with Oslo Børs or authorities with similar functions shall in this respect be deemed to be performing investment services and shall therefore not be considered as a Private Subscriber. A natural person whose vocation is giving investment services as defined above shall be deemed to be giving investment services and shall therefore not be considered as a Private Subscriber.

"Private Use": Private use shall mean Use of Information by a Private Subscriber for the purpose of managing the Private Subscriber's own personal investments and not for any business purpose, nor for the purpose of giving any form of advice to any other person.

A Private Subscriber may not:

- contract for, receive or Use Information for the purpose of Private Use on behalf of one or several other persons, limited liability
 companies or other entities with limited liability, general partnerships, trust companies, associations, corporations, joint properties or
 any other entities whatsoever
- contract for, receive or Use Information for the purpose of Private Use in any service that is paid for by one or several other persons, limited liability companies or other entities with limited liability, general partnerships, trust companies, associations, corporations, joint properties or any other entities whatsoever.

A Private Subscriber shall, notwithstanding the above:

• be permitted to contract for, receive or Use Information for Private Use on behalf of and/or paid for by a legal entity or other form of non-natural person in which the Private Subscriber has full (100%) ownership and exercises full (100%) control.

The Contracting Party and its Affiliate are required to obtain confirmation from Private Subscribers that the subscribers' status and Use of Information remain in compliance with this Agreement and take reasonable steps to ensure that Vendor is informed of any change in the status of Private Subscribers.

"Professional User": Any Subscriber not defined as a Private Subscriber.

"Professional Use": Any Use not defined as a Private Use.

In respect of Oslo Børs Information only, the Oslo Børs Snapshot Fees are paid instead of the Euronext Page View Fees described in the Information Product Fee Schedule.

No Oslo Børs Snapshot Fees are charged for the Use of Delayed Information.

Oslo Børs Snapshot Fees apply once per query to access Real time Information at any time within the relevant calendar month, per Information Product.

Oslo Børs Snapshot Fees are only available for Private Subscribers.

- the Oslo Børs Snapshot Fees are paid instead of the Euronext Page View Fees described in the Information Product Fee Schedule.

The Contracting Party and its Affiliates will not be charged Oslo Børs Private Use Fees for Trading Members for the Use of Delayed Information.
