### **CFD USE FEES**

CFD Use Fees are charged for the right to Use Real Time Information Product, in whole or in part, for the calculation and/or provision of prices for trading in contracts for difference (CFDs), spread betting, binary options and other instruments tradable on a CFD Platform in accordance with the Euronext Market Data Agreement (EMDA), Euronext Datafeed Subscriber Agreement (EDSA) and/or applicable Subscriber Terms and Conditions.

Depending on the scope of CFD Use the CFD Use Fees include a Basic CFD Licence Fee, CFD White Label Fees, and CFD User Fees.

No fees will apply to the CFD Use of Delayed Information.

### **BASIC CFD LICENCE FEES**

The **Basic CFD Licence Fees** apply once per Contracting Party, per Information Product.

If the values or prices resulting from CFD Use of the Information constitute Information, the applicable Redistribution Licence Fees, White Label Fees and Display Use Fees apply in accordance with the Euronext Market Data Agreement (EMDA) and in addition to the Basic CFD Licence Fee.

Where a Contracting Party is subject to the Real Time Redistribution Licence Fee and the Basic CFD Licence Fee, the highest of both Fees for the respective Information Product will apply.

### **CFD USER FEES**

The **CFD User Fees** apply if the values or prices calculated through the CFD Use of the Real Time Information constitute Original Created Works. The CFD User Fees for the applicable tier apply once per Contracting Party per information Product and in addition to the Basic CFD Licence Fee.

**Tier 1 CFD User Fees** – allows up to 500 (up to and including five hundred) Users to be enabled to access or trade on the CFD Platform(s) of, and/or in case of CFD White Label Services facilitated by, the Contracting Party.

**Tier 2 CFD User Fees** – allows up to 2.500 (up to and including two thousand five hundred) Users to be enabled to access or trade on the CFD Platform(s) of, and/or in case of CFD White Label Services facilitated by, the Contracting Party.

**Tier 3 CFD User Fees** – allows up to 10.000 (up to and including ten thousand) Users to be enabled to access or trade on the CFD Platform(s) of, and/or in case of CFD White Label Services facilitated by, the Contracting Party.

**Tier 4 CFD User Fees** – allows more than 10.000 (more than ten thousand) Users to be enabled to access or trade on the CFD Platform(s) of, and/or in case of CFD White Label Services facilitated by, the Contracting Party.

If the Contracting Party can and will provide (auditable) records/proof of the number of Active Users on Euronext's request, including during an Audit, the Contracting Party will be liable for the CFD User Fees based on the number of Active Users. For the purpose of this paragraph an Active User is defined as a User who during a particular month at one time held a position in an instrument where the value or price is calculated based on Real Time Information and constitutes an Original Created Work.

If a User has multiple accounts the Contracting Party is allowed to net these accounts with regard to the CFD User Fees, if it can be demonstrated that the account belongs to the same User. A Contracting Party needs to take into account all active accounts for CFD User Fees if this is not the case.

If the Contracting Party can provide proof, including during an Audit, that it already pays the Display Use Fees for a particular User for the respective Information Product, this User does not need to be taken into account for the CFD User Licence for such Information Product.

CFD White Label Fees are charged in addition to the respective Basic CFD Licence Fees and CFD User Fees.
