## 1. INTRODUCTION

---

This document provides all multicast and TCP/IP addresses required to access the Euronext Optiq® External User Acceptance (EUA) for Optiq Snapshot and MDG Lite services. The document should be read in conjunction with the Euronext Cash and Derivatives Markets – Optiq MDG External User Acceptance Connectivity document, in order to derive a combined view of the Euronext EUA available services.

Only shaped data is provided in the test environment. In order to ensure a Production-like test environment, separate IP addresses and ports are used to replicate the Production ‘shaped’ and ‘unshaped’ configuration.

The Euronext Optiq® Market Data Gateway Next Release-EUA (P-EUA) and the Current Release-EUA (V-EUA) environment are located in Bergamo. The P-EUA and V- EUA Source IP Address ranges are provided in this document and for P-EUA the Source IP Address ranges are provided for the live and standby systems as part of the High Availability mechanism. EUA High Availability (HA) and failover testing will only be conducted on the Next Release test environment (P-EUA).

Customers are requested to allow the P-EUA Source IP Address ranges through their Firewalls. The Connectivity details for V-EUA environments of Optiq Snapshot and MDG Lite services will be provided in due course.
