

MiFID II: SATURN NEW transaction recovery feature – CANCEL AND REPLACE

Summary

Euronext informs customers that a new version of the Saturn Regulatory Reporting Solution is available in P-EUA and production.

This release of Saturn includes the new "Transaction Recovery" functionality.

Following the request of several members and regulators, Euronext has implemented a new feature into Saturn APA/ARM platform called "Transaction Recovery". This process will allow members to recover archived transactions from the database, make updates and report these updates to their relevant regulator, in a fully automated way. It is available via file upload.

The purpose of this Notice is to explain how this new functionality will work in order to allow both clients and regulators to anticipate impacts. Below are some key highlights of this new functionality:

- The value [4: Recovery] has been added in the "Action" field, to allow customers to launch this process and on Euronext side trigger the recovery of the transactions.
- The full recovery process can take up to 48h until Regulators validation.
- The usual Saturn checks on the modified declarations will be done the day following the file recovery and modified declarations will be sent the evening of that day if all controls are successful.
- On the other end of the process, the 'Action' field is not included in the reports to regulators. The regulators will see exactly the same type of information as for modifications non-archived transactions (i.e. same types of fields, same range of values). The usual trade counting and databases adjustment are to be done on regulators' side. The only difference with modification of non-archived transaction is that it will impact older transactions that are potentially archived on regulators' side; in case specific controls are in place, these would have to take into account this new possibility.
- It only concerns the reporting services : ARM APA&ARM OBOE&ARM

User guide

To UPLOAD a Recovery File:

Members should only add the fields they are willing to amend in the header. These fields have to be populated.

WARNING : DO NOT leave fields blank in your upload. If you do, you will lose the data previously entered into Saturn (Saturn will change the value to Default = Blank).

Members can perform a mass upload of recovery requests in a CSV file. A recovery file must contain **ONLY** recovery requests (value [4: Recovery] in the "Action" field).

1. Enter the key data that allows to retrieve the corresponding transaction in the file to be uploaded.

- 2. Update the others fields with the correct values to be stored in the transaction after recovering
- 3. Choose Action = 4 (Recovery) in the file and Upload it by clicking on the menu

Submit a csv file with amend requests [action=2:Amend] in the "Action" field) and replace the amendable field with the new value.
